RULES: Current NRA Conventional Pistol Rules will govern.

SOUVENIR PINS: Provided by NRA.

CLASSIFICATION: The NRA Classification system will be used in all matches, Individuals who are not classified will fire in the Master class.

CATEGORIES & CLASSES: Class awards will be given in each of the three categories Civilian Police and Service (Rules 2.2-2.4-2.5-2.6-2.7) subject to the conditions of the award schedule.

SENIOR CATEGORY: An award will be provided in Match # 19 if two (2) or more seniors register.

CHALLENGES: A challenge fee of \$ **3.00** will be charged for each challenge made (Rule 16.1)

SQUADDING: All matches will be squadded by the statistical office NRA membership card and classification cards will be checked at that time.

In the class and category awards there must be at least 5 competitors to establish competition 8 or more for a second place award and 12 or more for a third place award.

If there a fewer than 5 entries in a category the will be combined with entries of another category in the same class. If there are fewer than 5 after combining all categories of a class, there will be NO AWARD in that class. Competitors of a lower class will not be combined with High Masters / Masters. If there are less than 5 High Masters /Masters they will compete for open awards only. Any individual or team who wins an Open Award will not be entitled to a class award in the same match.

SPONSOR AWARDS: Individual Fired Matches, Sub Aggregate Matches, and Team Match. Open awards 1st place 8 points, 2nd place 4 points, 3rd place 3 points, there must be 8 or more competitors for a second award and 12 or more for a third award.

Class and category awards: 1st place 5 points, Second place 4 points, Third place 3 points There must be 5 or in a class or category for 1st place award 8 or more for a Second place award and 12 or more for a Third place award. **Team award**; 2nd place will be no less than entry fees paid

NOTE: Awards will be in the form of NRA awards points or check, (sponsors choice) and will be enclosed with the final match bulletin.

COURSE OF FIRE : National Match Course. (30 Rounds)

Stage 1 = Slow fire, 50 yds at B-6 target ,2 (5) shot strings,5 min per string.
Stage 2 = Timed fire,25 yds at B8 target,2 (5) shot strings 20 sec per string.
Stage 3 = Rapid fire, 25 yds at B-8 target,2 (5) shot strings,10 sec per string.

FIREARM: Pistol US Caliber 45 1911/1911A1 with a trigger pull of no less than 4 Lbs 6.4.1
Pistol Caliber 9MM, Model 9 as issued to the Military Services,or Bretta Model 92FS or a civilian equivalent such as a Taurus 6.4.2

AMMUNITION : As Military issue ammunition is not available from DCM/CMP the following may be used: 6.6.2(1) (2) .45 ACP :Any "safe" ammunition with 230 grain full metal jacket, RNB 9MM : Any "safe" ammunition with 115-125 grain full metal jacket , RNB
