RULES: Current NRA rules will govern throughout the tournament. Competitors will change targets and score and are expected to bring a staple gun and staples (and tape?). The use of plug type scoring devices is limited to the NRA REFEREE only (Rule 14.3.1). EYE AND EAR PROTECTION REQUIRED.

ELEGIBILITY: The Regional tournament does not require proof of National Rifle Association membership, but NRA membership is encouraged. Teams will consist of four firing members, one alternate and one captain and/or coach and will represent either a club affiliated with the N.R.A. (Rule 2.11), a law enforcement agency (Rule 2.14), a regular service or reserve unit (including the National Guard, Rule 2.13). The team captain and/or coach may be firing members of the team. Sate Association teams may enter the team matches (Rule 2.12). (State Association membership required) Pick-up teams are not allowed in a Pistol Regional. (Rule 2.10).

ENTRY INFORMATION: Entries are limited to two relays of 30 shooters each, assuming all entries are 3 gun shooters. Across the board entries are given preference and other entries will be accepted only if space permits.

All reserved entries must be received by mail or telephone no later than 9:00 p.m. on Thursday, June 3, 2010. Entries will be acknowledged if requested. Post entries are accepted up to the limit of the range, provided no additional relay is required. Mail entries to and obtain additional information from:

SQUADDING: Matches will be squadded and competitors must check in with the Stat Office 30 min. prior to the start of their relay for their score cards. Firing points will be assigned by drawing.

CHALLENGES: A fee of \$1.00 will be charged for each challenge. The Referee will be the sole authority for the resolving of challenges. Challenge time for the range bulletin closes 1 hour after the final score posted.

CLASSIFICATION: N.R.A. classification system will be used in all matches. Rule 19.6 may be used in making entry in an N.R.A. Regional Tournament. Rule 19.7 will apply to anyone without proof of classification.

CATEGORIES AND CLASSES IN MATCHES: Separate class awards be given in each of three categories: Civilian, Service, and Police, subject to the conditions of the award schedule. Members of the active Army, Navy, Marine Corps, Coast Guard, Air Force and National Guard and Reserve Components will make up the Service Category. Members of the Federal, State, County, Municipal Law Enforcement Groups and industrial Police (Rule 2.4) comprise the Police Category. All others will be considered Civilians (Rule 2.2).

SOUVENIR AWARD: A souvenir award will be issued to each competitor.

NRA/USA CIVILLIAN PISTOL TEAM PROGRAM: Competitors may check at the entry office for eligibility requirements and information on this program.

FIRING SCHEDULE: The first relay will start the 3 minute preparation period promptly at 7:57 a.m. each day. The second rely is estimated to begin about 9:30 a.m. We shoot rain or shine! Matches must be shot on date scheduled.


