RULES: Current NRA pistol rules will apply.

SCORING: Competitors will score and change targets. Scoring plugs will be restricted to

range personal only. A fee of \$2.00 will be charged for each challenged target.

Fee will be returned if challenge is sustained.

CLASSIFICATION: NRA classification system will be used. Any class with less than five

entries will compete in the next higher class. If there are less than five entries in the master class, they will compete for match winner only.

EXCELLENCE IN COMPETITION MATCH (LEG MATCH) AND REVOLVER DISTINGUISHED

NOTE: The EIC Match will be governed by the current edition of CMP Rules.
