**DATE:** August 19, 2012    **Starts 9:00 am**    **LOCATION:** Oakdale Gun Club, Lake Elmo, MN

**OFFICIALS:** OFFICIAL REFEREE, NRA TO ASSIGN

**ELIGIBILITY:** Minnesota residents must be members of the MRRA.

**RULES:** Current NRA pistol rules will apply. Challenge fee \$1.00. The referee will be the sole authority for resolving challenges. The use of plug type scoring devices is limited range officers and the Referee.

**CLASSES:** NRA Classification system will be used. Those not so classified must shoot in the Master Class.

**ENTRY INFO:** Entries are limited to 30 shooters. Across the board entries are given preference. Post entries will be accepted if they do not require opening another relay.

**ENTRY FEES:** Fee for matches 1 to 16 is \$40.00. The entry fee for 1 gun is \$20.00, any 2 guns is \$30.00. Preference is given to advanced registration, and secondly to three gun shooters over two or one gun shooters. Fee for match 17 will be \$15.00. Fee for match 18 will be \$15.00. Fee for match 17 AND 18 is \$20.00.

**GUNS:** Any Pistol or Revolver complying with NRA Rules.

**NOTES:** Competitors will score and repair targets. Bring your staple gun and staples. Eye and hearing protection is mandatory. Alcoholic beverages are prohibited at the match and on club property. We start promptly at 9:00 AM and shoot rain or shine. No lunch is provided, there are restaurants nearby.

**MATCH 17:** The CMP SERVICE PISTOL MATCH, sponsored by Minnesota Rifle & Revolver Association.

**ELIGIBILITY:** Open to all citizens of the United States 12 years or older on the date of the match.

**TIME & DATE:** 30 minutes after the completion of match 15.

**FEE:** The CMP service pistol match will be \$15.00.    **COURSE:** 30 shot National Match Course.

**FIREARM:** "Service Pistol" as defined in the Civilian Marksmanship Program Competition Rule (6.3). The referee will weigh all triggers prior to the start of this match.

**ENTRIES:** Limited to 30 shooters, minimum of 7 non-distinguished.

**AWARDS:** Points toward "distinguished" designation. All awards by and per CMP rules.

**RULES:** In accordance with the current Civilian Marksmanship Program Competition Rules governing the National Trophy Rifle and Pistol Matches and Excellence-In-Competition (EIC) Matches.

**MATCH 18:** The NRA Distinguished Revolver (DR) Match, sponsored by Minnesota Rifle & Revolver Association.

**ELIGIBILITY:** Open to any able-bodied citizen of the United States, 16 years of age or older on the date of match.

**TIME & DATE:** Following Match 17    **FEE:** \$15.00    **COURSE:** 30 shots, National Match Course.

**FIREARM:** "REVOLVER" as defined in NRA rule 3.1. All triggers will be weighed prior to the start of the match.

**ENTRIES:** Limited to 30 shooters. Minimum of 6 entries.

**AWARDS:** Credit toward "Distinguished" designation.    **RULES:** In accordance with NRA DR rules.
