**ELIGIBILITY:** 

Open to members of the NRA, juniors who are members of NRA affiliated clubs and members of the Armed Forces (Active, Guard and/or Reserve) of the United States of America. Iowa residents must be members of the lowa State Rifle and Pistol Association. Non-residents must be members of their home state association. Be prepared to show membership cards.

Applications for the lowa State Rifle and Pistol Association will be available.

**ENTRIES:** 

Entries will be limited to 48. Two relays will shoot on each of the two days of the match. Competitors will fire the entire match in one day. Post entries will be accepted to range capacity. Competitors will be notified ONLY if the relay they desire is full. Entries will be squadded and "across the board" entries will be given preference.

MATCH FEES:

Registration fee is \$9.00. Entry fees are \$2.50 per individual match. Across the board entry fee is \$40.00 which includes the registration fee.

RULES:

Current NRA rules for indoor pistol competition will govern the match. Alibies and refires will be allowed. A \$1.00 fee will be charged for each challenge. Sponsors will post, score and change targets. Scores become official 1 hour after all same day match scores are posted.

CLASSIFICATION: The NRA classification system will be used. Competitors will provide proof of classification at time of entry. Unclassified competitors will fire in their own class. Any class with fewer than 5 competitors will be combined with the next higher class. Four competitors must be entered in the High Master/Master class before a first Master award will be given. Competitors will not be separated into catagories.


