**ELIGIBILITY:** Open to any shooter who is a member of the NRA. Minnesota residents must be members of the MRRA.

**RULES:** Current NRA pistol rules will apply. Challenge fee \$1.00. The referee will be the sole authority for resolving challenges. The use of plug type scoring devices is limited range officers and the Referee.

**CLASSES:** NRA CLASSIFICATION SYSTEM WILL BE USED. Those not so classified must shoot in the Master Class.

**ENTRY INFO:** Entries are limited to 30 shooters. Across the board entries are given preference. Post entries will be accepted if they do not require opening another relay.

ENTRY FEES: 42.50 per match + \$5.00 registration fee. Package fee for matches 1 to 16 will be \$45.00. The entry fee for 1 gun will be \$23.00 any 2 guns \$35.00. NRA award points will be accepted. **Preference given to advanced registration, and secondly to three gun shooters over two or one gun shooters.**

## LEG MATCH INFORMATION

- MATCH 18** the CMP SERVICE PISTOL MATCH, sponsored by Minnesota Rifle & Revolver Association.
- ELIGIBILITY** the competition is open to all citizens of the United States 12 years or older on the date of the match.
- TIME & DATE** Approximately 30 minutes after the completion of the 45 cal match, but not before 2:00 PM on Saturday September 5, 2009.
- FEE** The DCM service pistol match will be \$10.00 cash. (Entry Fees include Sales Tax)
- COURSE** 30 shot National Match Course.
- WEAPON** "Service Pistol" as defined in the Civilian Marksmanship Program Competition Rule (6.3). The referee prior to the start of this match will weigh all triggers.
- ENTRIES:** Entries will be limited to 2 relays of 30 shooters. In the event the limit is reached an additional relay will be added.
- AWARDS** Credit towards "distinguished" designation. All awards by and per CMP rules.
- RULES** In accordance with the current Civilian Marksmanship Program Competition Rules governing the National Trophy Rifle and Pistol Matches and Excellence-In-Competition (EIC) Matches.
- NOTE** **THERE MUST BE AT LEAST 7 NON-DISTINGUISHED SHOOTERS TO HAVE A LEG MATCH.**
