DATE: Sunday, July 26th, 2009

LOCATION: The Valley City, N. Dak. Outdoor Range is located North and East of the High Line Railroad Bridge on the north side of Valley City. Proceed ¼ mile north of the bridge, cross the RR tracks at the grain elevator and turn east on the gravel road to the range.

RULES: Current NRA Pistol Rules will govern. Open to any NRA Member. N.Dak. Residents must be NDSSA Members. Memberships will be available at the range. Tournament Officials may not compete.

RELAYS: Sunday Morning at 8:57 sharp. Only one Relay.

RANGE & CAPACITY: The range has 20 covered firing points with tarp wind protection. Slow Fire will be at 50 yds. On B-6 Targets. Timed and Rapid Fire will be at 25 yds. with turning targets on B-8 Targets. Capacity for the tournament will be 20 shooters.

ENTRIES CLOSE: 10:00 p.m. Thursday, July 25th, 2009

POST ENTRIES: Post entries will be accepted up to range capacity. No Post Entry fee, but advanced entry is requested, Please. Priority will be given to competitors entering all matches.

Shooters without an Outdoor Classification may use their Indoor Classification. The range road is in good condition, so access should not be a problem. The grill will be out and Brats available at the range.
