**Eligibility:** A competitor may enter only one NRA Sectional of each type during 2011.

**Rules:** Current NRA rules will govern. .22 cal. Conventional Pistol 3.4, Standard Pistol 3.5, Air Pistol 3.7, Free Pistol 3.6

**Targets:** Conventional B-2 and B-3 (50 ft), Standard Pistol B-33 (50 ft), Air Pistol B-40 (10 m), Free Pistol B-11 (50 ft).

**Classification:** Current NRA classification will be used. All unclassified shooters will fire in the Master Class. Categories will be used on national competition and not be used for local competition.

**Relay Times:** Air Pistol will be an open gallery from 10:00am to 4:00pm, Saturday and Sunday, held in the classroom.
