**ELIGIBILITY:** OPEN, NRA MEMBERSHIP ENCOURAGED BUT NOT REQUIRED.

**ENTRIES:** LIMITED TO 28 IN TWO RELAYS. POST ENTRIES ACCEPTED TO RANGE CAPACITY, PREFERENCE GIVEN TO ACROSS THE BOARD REGISTRANTS.

**RULES:** NRA RULES WILL GOVERN MATCH. \$2.00 CHALLENGE FEE.

**CLASSIFICATION:** NRA CLASSIFICATION SYSTEM WILL BE USED. UNCLASSIFIED COMPETITORS WILL FIRE IN THE MASTER CLASS. ANY CLASS WITH LESS THAN 5 WILL BE COMBINED WITH THE NEXT HIGHER CLASS STARTING WITH MARKSMAN CLASS. LESS THAN 5 MASTERS WILL SHOOT FOR WIN ONLY.
