Entry fees will be refunded on a daily basis in the event of a match cancellation.
Preregistration fees will be refunded if non-attendance notice is received prior to 4:00 PM on Friday, September 6th.

CLASSIFICATION: The NRA classification system will be used in all individual matches. Please have your NRA classification card or temporary score book with you. Shooters without a classification card will shoot in the Master/Unclassified (MU) class (rule 19.6).

RIFLES: NRA Match rifles, Palma rifles, Service Rifles. As allowed by NRA Rules. Rifles may be changed for various matches at the discretion of the competitor.

RULES: Current NRA High Power rules will govern the Matches and Rifles.

AWARDS: Trophies and Plaques according to MRRA Standards. Awards will be given in each class where there are 5 or more competitors in that class. The 10% rule will apply. Forty (40) percent of the Tournament Fee will be awarded to individual competitors. Actual prizes awarded will be based on the total number of entries. Individual Class awards will be recognized.

ENTRIES: Advance entries are strongly encouraged and will be given priority entry. Advance entry, accompanied with fees, is required for choice of relay. Entries will be capped at 36 shooters. Advance entries will close at 4:00 P.M. on Friday, September 6, 2019. We will hold your entry until one hour before the match begins. If you have not registered by that time your spot will be made available to another participant. Entries will be accepted up until 8:30 A.M. on Saturday, September 7th, dependent on the number of advanced entries for both days until the limit of 36 shooters is reached, whichever comes first. SQUADDING: Squading will begin at **0900 Saturday 0800 Sunday**. High masters will be squaded on relay 1 to the extent possible. Pre-registration, accompanied with fees, will be given priority.

MATCHES: Sat: Match 1: Any sight. A maximum of two sighting shots and 20 shots for record (500 Yards) Match 2: Any sight. A maximum of two sighting shots and 20 shots for record Match 3: Iron sight. A maximum of two sighting shots and 20 shots for record Match 4: Iron sight. A maximum of two sighting shots and 20 shots for record Match 5: Aggregate of Matches 1 through 4

MATCHES: Sun: Match 6: Iron sight. A maximum of two sighting shots and 20 shots for record (300 Yards) Match 7: Iron sight. A maximum of two sighting shots and 20 shots for record Match 8: Any sight. A maximum of two sighting shots and 20 shots for record Match 9: Any sight. A maximum of two sighting shots and 20 shots for record Match 10: Aggregate of Matches 1 through 9

DUTIES: Competitors will be required to score and pull targets. Failure to perform these duties will result in disqualification.

The range will be open for camping from 1200 on Friday, September 6th through 1000 on Monday, September 9th. Electric hook ups for campers are available. Clean outhouses are provided. The Education Center, lake cabin and 16 yard shack will be made available for overnight use on Friday, Saturday and Sunday.
